ORDER

2. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **District Institute of Education and Training, Bhaissau, Kanpur Dehat - 209205, Uttar Pradesh** for an additional intake of **50 to the BTC (Elementary)** course of two years duration, thereby making the total intake of the Institution to 150 i.e. 150 in the 1st year and the same for the 2nd year w.e.f the academic session 2006-2007 at the following address:-

3. The Institution shall ensure the fulfilment of the following:-

- The institution shall maintain the teaching staff strength of **1+15 for the BTC Course.**
- The Institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- The Institution shall regularly update its website.

4. If the Institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
