- 3. The institution shall ensure the fulfillment of the following:-
 - The institution shall maintain the teaching staff strength of 1+3 for the proposed B.P.Ed. Course.
 - The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - c. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - d. That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
 - f. The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
 - The institution shall regularly update its website.
