ORDER

15 NOV 2006

Siyaram Kasturi Devi College of Education, F-19, Shastri Nagar, Meerut, Uttar Pradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of permission of additional intake in B.Ed. Course in terms of section 15(1) of NCTE Act, 1993.

2. The NRC at its 109th (2nd sitting) meeting held on 10th November 2006 at NCTE, Hqs. considered application of the institution including in the agenda for the meeting and after careful examination of relevant documents found the institution fit for grant of permission.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to upgrade the annual intake of two units in **B.Ed. course** of One year duration **w.e.f. the session 2006-2007** with an additional intake of 100 (**One Hundred only**) making the total two hundred (100+100=200) students to **Siyaram Kasturi Devi College of Education, F-19, Shastri Nagar, Meerut, Uttar Pradesh** at the following address:-

4. The institution shall ensure the fulfillment of the following:-
- (a) Selection of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliating University given effect before the commencement of the course.
 - (b) The institution shall maintain the teaching staff strength of 1:14 for the proposed B.Ed. Course.
 - (c) The institution shall note that with regard to NET/SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
 - (d) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (e) The Institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - (f) That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
 - (g) Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
 - (h) The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
 - (i) The institution shall regularly update its website.

5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993. The NCTE Hqrs may also cause inspections under section 13 of the NCTE Act, 1993.
