**ORDER**

WHEREAS **Ishan Institute of Management Technology, 2 Knowledge Park - I, Greater Noida, Distt. - G.B. Nagar, U.P.** had applied for grant of recognition (UP - 2084) for B.P.Ed. course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the Institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 110<sup>th</sup> meeting held on 10-12 Nov 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 20.11.2006 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS the applicant institution had not submitted any representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC on 28-30 July 2007 which came to the conclusion that recognition to the said institution be refused for the following reasons.

- Facilities for athletics are not available.
- Facilities for physiology lab are not available.
- Auditorium is under construction.
- No facility for anatomy gymnasium are available.
- The number of books added in the library is only 155, whereas the visiting team is of the view that a minimum of 1500 books are required for effective curriculum transaction.
- Facilities for language learning not provided.
- The institution to appoint the qualified staff by a duly constituted selection committee as per NCTE Norms/State Govt/Affiliating University.

5. NOW THEREFORE grant of recognition to **Ishan Institute of Management Technology, 2, Knowledge Park - I, Greater Noida, Distt. - G.B. Nagar, U.P.** for the course in B.P.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.

7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
