

#### ORDER

WHEREAS Krishna Sudama Mahavidyalaya, Village – Maradapur, Post – Daulatpur, Distt. – Ghazipur, U.P. had applied for grant of recognition (UP - 2101) for B.P.Ed. course one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 114<sup>th</sup> meeting held on 10<sup>th</sup> Nov 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice to the applicant institution under provise to section 14(3)(b) of the NCTF Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 3. AND WHEREAS the applicant institution had submitted representation dated 15.4.2007. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by Northern Regional Committee on 23-25/6.2007 wherein the committee decided that fresh inspection of the institution be conducted to verify the facts claimed by the institution in its written representation.
- AND WHEREAS the competent authority had constituted a Visiting Team to second visit the institution and the visiting team had since submitted its report.
- 5. AND WHEREAS in its 123<sup>rd</sup> meeting held on 19-22 Nov 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:
  - Hall is under construction.
  - Only 1000 books are provided for the B.P.Ed course.
  - · Multiple sets of apparatus not provided in Science lab
  - Chemicals and consumables in the required quantity has not been procured.
  - CD Roms, Access to Internet, OHP, TV, VCR, Public Address System not provided.
  - · Facilities for Language learning not provided.
  - · Website of the Institution has not been launched.
- NOW THEREFORE grant of recognition to Krishna Sudama Mahavidyalaya,
  Village Maradapur, Post Daulatpur, Distt. Ghazipur, U.P. for the course in
  B.P.Ed. in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
