WHEREAS in terms of Section 15(1) of the NCTE Act, **Bhagwanti Education Centre Degree College, Sandilla, F.No. 130A, 130B, Mandhana, Bithoor Road, Bilhore, Kanpur, U.P. - 209217** has submitted an application (code No. 04655) to the Northern Regional Committee of NCTE for grant of recognition for **B.Ed. Course** of one year duration with an additional intake in existing B.Ed. course of **100 (One Hundred Only)** students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition, **Bhagwanti Education Centre Degree College, Sandilla, F.No. 130A, 130B, Mandhana, Bithoor Road, Bilhore, Kanpur, U.P. - 209217** for conducting **B.Ed. Course** of one year duration with an additional intake in existing B.Ed. course of 100 (One hundred Only) (one unit), thereby making the total intake of the institution to 200 (Two hundred only) (Two Unit) under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:

- (i) The institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

If the institution contravenes any of the above conditions or any of the provisions of NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional

committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

7. The institution shall maintain & update the Website as per provisions of NCTE Regulations.

8. The staff appointed is to be rectified by the affiliating body and the copy of same is to be submitted to this office for records.
