**ORDER**

WHEREAS **Shri P.L. Verma T.T. College, Village – Dakauli, Post – Khurda, Mardarpur, Distt. – Hardoi, U.P.** had applied for grant of recognition for BTC course two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its **101<sup>st</sup> meeting held on 22-24 February 2006** the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant Institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **17.4.2006** to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

3. AND WHEREAS the applicant institution had submitted representation dated 22.2.2008. The said representation of the institution as well as other documents and materials submitted by the Institution along with VTR and videography were again duly considered by Northern Regional Committee on 9-11 August 2008 which came to the conclusion that recognition/ permission to the said institution be refused for the following reasons:

(a) **Supporting documents not given.**

4. NOW THEREFORE grant of recognition to **Shri P.L. Verma T.T. College Village – Dakauli, Post – Khurda, Mardarpur, Distt. – Hardoi, U.P.** for the course in **BTC** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
