 - The institution shall, within one month of the receipt of recognition order, convert (i) the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - The institution shall comply with the various other norms and standards (11) prescribed in the NCTF regulations, as amended from time to time.
