ORDER

WHEREAS Shri Ram College of Education, NH, Gajraula, J.P. Nagar, U.P. had applied for grant of recognition (UP - 2096) for 8.P.Ed. course one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 112th meeting held on 27-28 December 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 03.01.2007 to the applicant institution under provise to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf. The institution has submit reply on 3.2.2007 and place in NRC in its 119 meeting wherein the NRC decided to final notice documentary evidence in reply to the SCN not submitted. Accordingly final notice issued on 6.9.2007.
 - 8. AND WHEREAS the applicant institution had submitted representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC on 8th -10th January 2008 which came to the conclusion that recognition to the said institution be refused for the following reasons.
 - (a) The institution has not submitted the fresh Video CD of the institution and the reply submitted by the institution is not satisfactory according to the Norms and Standards of NCTE.
 - NOW THEREFORE grant of recognition to Shri Ram College of Education, NH, Gajraula, J.P. Nagar, U.P. for the course in B.P.Ed. in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
