 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the ac demic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the ement of 180 teaching days in the session is fulfilled as per calendar of the resity/Affiliating Body.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
