WHEREAS, the **Rudra Institute of Technology, Rasoolabad, Nanpur, Garh Road, Ghaziabad**, was granted recognition for running B.Ed. of one year duration with an annual intake of 100 students under clause 7(12) of Regulation dated 13.1.2006 vide this office order no. F. NRC/NCTE/F-7/UP-2776/2008 /50453-59 dated 14.5.2008.

2. AND WHEREAS, the inspection of the institution was conducted on 2.4.2009 under section 17 of the NCTE Act 1993. Northern Regional Committee in its 139 meeting held on 10-13 April 2009 after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a Show Cause Notice on 17.5.2009 to the applicant institution under proviso to section 17 of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

3. AND WHEREAS the applicant institution has submitted representation on 8.5.2009. The original file of the institution as well as other documents and VTR were again duly considered by Northern Regional Committee in its 141<sup>st</sup> meeting held on 22-24 May 2009 which came to the conclusion that recognition to the said institution be withdraw for the following reasons:

- **The College building was not in existence at the time of inspection under section 14. The Management showed the building of Mohan College of Teacher Education, Baral Partapur, Meerut at the time of said inspection.**

4. NOW THEREFORE grant of recognition **Rudra Institute of Technology, Rasoolabad, Nanpur, Garh Road, Ghaziabad, U.P.** for the course in B.ED. in term of section 17 of the NCTE Act, 1993 is hereby withdraw.

5. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993 and original FDR Rs. Five lacs no. 663854 dated 27.12.2007 is return herewith.
