REFUSAL ORDER

9 JUL 2009

WHEREAS AMITY UNIVERSITY, DEPARTMENT OF EDUCATION, PLOT NO. 4, SECTOR - 125, NOIDA, DIST. - G. B. NAGAR, UP. Had applied for grant of recognition (UP-2051) for B.P.ED. Course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 109<sup>th</sup> meeting (Second sitting) and 110<sup>th</sup> meeting on 10<sup>th</sup> November, 2006 and 11<sup>th</sup> - 12<sup>th</sup> November, 2006 at NCTE Hqrs. New Delhi, considered application of the institutions and after careful examination of relevant documents, Visiting Team Reports, Video Recording, Original file etc. found the institutions fit for grant recognition of the B.P.ED. Course subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliation University/Body given effect before the commencement of the course. Accordingly letter of intent prior to recognition was issued to the institution on 14.11.2006.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. NOW THEREFORE grant of recognition AMITY UNIVERSITY, DEPARTMENT OF EDUCATION, PLOT NO. 4, SECTOR - 125, NOIDA, DIST. - G. B. NAGAR, UP. For the course in B.P.ED. In term of section 15(1) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
