REFUSAL ORDER

WHEREAS VEER BAHADUR SINGH MAHAVIDYALAYA, HARNAHI, POST - MAHURAON, GORAKHPUR-273406, UP. had applied for grant of recognition (UP-2110) for B.P.Ed. COURSE one years(s) duration under section 15 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 114th meeting held on 21st - 22nd February 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Government/Affiliating University/Body given effect before the commencement of the B.P.Ed. Course. Accordingly letter of intent prior to recognition was issued to the institution on 23.02.2007.

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in NRC in its 141 meeting held on 22-24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

4. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

5. NOW THEREFORE grant recognition to VEER BAHADUR SINGH MAHAVIDYALAYA, HARNAHI, POST - MAHURAON, GORAKHPUR-273406, UP. for the course in B.P.ED course is hereby refused.
