- 3. AND WHEREAS in its 112<sup>th</sup> meeting held on 27<sup>th</sup> and 28<sup>th</sup> December 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and ask the institution to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Government/Affiliation University/Body given effect before the commencement of the B.Ed. course Accordingly letter of intent prior to recognition was issued to the institution on 29.12,2006

  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 6. NOW THEREFORE grant of recognition VEER BAHADUR SINGH MAHILA MAHAVIDYALAYA, SANJAY GANDE! PÜRAM, FAIZABAD, ROAD, LUCKNOW, UP. for the course in BTC is hereby refused.
