ORDER

WHEREAS, the SARDAR SINGH SHIVRAJ SINGH MAHAVIDYALAYA, RAGHUBEER NAGAR, SITAPUR, U.P. was granted recognition for running B.Ed. of one year duration with an annual intake of 100 students vide this office order no. F. NRC/NCTE/F-3/UP-946/3830-3838 dated 6.7.2004.

2. AND WHEREAS, Northern Regional Committee in its 137 meeting held on 28th February & 1st March 2009 after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a Show Cause Notice on 27.3.2009 to the applicant institution under proviso to section 17 of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

3. AND WHEREAS the applicant institution has submitted representation on 9.4.2009. The original file of the institution as well as other documents and VTR were again duly considered by Northern Regional Committee in its 141st meeting held on 22-24 May 2009 which came to the conclusion that recognition to the said institution be withdraw for the following reasons:

- From the reply submitted by the Institution, it is clear that the deficiencies pointed out on the basis of Inspection conducted under section 13 exist. The reply submitted by the Institution is not found to be satisfactory.

4. NOW THEREFORE grant of recognition SARDAR SINGH SHIVRAJ SINGH MAHAVIDYALAYA, RAGHUBEER NAGAR, SITAPUR, U.P. for the course in B.ED. in term of section 17 of the NCTE Act, 1993 is hereby withdraw.

5. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993 and original FDR Rs. Five lacs no. 663854 dated 27.12.2007 is return herewith.
