REFUSAL ORDER

WHEREAS V.K. JAIN COLLEGE OF EDUCATION, SORON ROAD, KASGANJ, ETAH-207123, UP. had applied for grant of recognition (UP - 2630) for B.Ed. Additional intake of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 138th meeting held on 14th 16th March, 2009, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 24.03.2009 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
 - 12. AND WHEREAS the applicant institution had not submitted any representation to Northern Regional Committee, NCTE. The said representation of the institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 141° Meeting held on 22° 24° May, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.
 - (a) The number of books is not as per NCTE Norms.
 - (b) The computers are still insufficient.
 - NOW THEREFORE grant of recognition to V.K. JAIN COLLEGE OF EDUCATION, SORON ROAD, KASGANJ, ETAH-207123, UP. for the course in 8.Ed. Additional intake in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
