REFUSAL ORDER

WHEREAS **Smt. Ram Rati Gupta Women's Polytechnic College, Rampur, Maniharan, Saharanpur, U.P.** had applied for grant of recognition (UP-2138) for BTC. Course of two years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 127th meeting held on 27th - 29th March, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to **issue a letter of conditional recognition and ask the institution to (i) Appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliating University given effect before the commencement of the course. (ii) Send a blue print of the building plan showing clearly demarcated area for B.Ed. (Add.), M.Ed. Programme. (iii) Advertisement notice. (iv) Consolidate staff list on the prescribed format duly approved by the affiliation body. (v) Proceedings of the Selection committee along with a copy of the letter form the affiliating body nomination a member for the selection. Accordingly letter of conditional recognition was issued to the institution on 26.05.2007.**

4. AND WHEREAS the applicant institution has submitted reply dated 14.09.2007. The matter was placed in NRC in its 141st meeting held on 22nd -24th may 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- **The list of appointed Faculty as per NCTE Norms has not been submitted till date.**

5. AND WHEREAS the committee decided to refused recognition for BTC. Course and return FDRs if submitted.

6. NOW THEREFORE grant of recognition **Smt. Ram Rati Gupta Women's Polytechnic College, Rampur, Maniharan, Saharanpur, U.P.** For the course in BTC. is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
