RESUSAL ORDER

WHEREAS UDAI PRATAP AUTONOMOU COLLEGE, VARANASI, VARANASI- 221002, UP. had applied for grant of recognition (UP-Z171) for E.P.ED. Course one years(3) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team submitted its report on 19.04,2007.
- 3. AND WHEREAS in its 116th second sitting meeting held on 7 8 May 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue letter of intent prior to recognition under section 7(11) of NCTE regulations dated 27.12.2005. Accordingly letter of intent prior to recognition was issued to the institution on 28.5.2007 with following direction for further consideration of recognition of the said course.
- (i) Appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt. /Affiliating University given effect before the commencement of the course.
- (ii) Send a blue print of the building plan showing clearly demarcated area for B.Ed. Add. And M.Ed. Programme.

(iii) Advertisement notice.

- (iv) Consolidate staff list on the prescribed format duly approved by the body.
- (v) Proceeding of the selection committee along with a copy of the letter form the affiliating body nomination a member for the selection.

(Vi) Library is to be upgraded as per NCTE norms.

- (Vii) Infrastructural facilities for 6.P.Ed. Course are to be upgraded as per NCTU norms.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in VRC in its 141 meeting held on 27 24 May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.
