REFUSAL ORDER

WHEREAS SONPATI DEVI MAHILA MAHAVIDYALAYA, MAHARAJGANJ, JANPAD, MAHARAJGANJ, UP, had applied for grant of recognition (UP-2424) for B.ED. Course of one year(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 120th meeting held on 12th - 13th August, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter Prior to grant of recognition and ask the institution to Provide appoint the staff as per NCTE norms i.e. the Selection Committee is to be constituted as per policy of the State Government/Affiliating University/ Affiliating Body/UGC. The institutions are required to submit an Affidavit on Rs. 100/- stamp paper from the Management of the institutions and Affidavit on Rs. 10/- stamp paper from the staff appointed. Accordingly letter Prior to grant of recognition was issued to the institution on 16.08.2007.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141st meeting held on 22nd -24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for B.ED. course.

6. NOW THEREFORE grant of recognition SONPATI DEVI MAHILA MAHAVIDYALAYA, MAHARAJGANJ, JANPAD, MAHARAJGANJ, UP, for the course in B.ED. is hereby refused.
