WHEREAS Dayanand Danku Paraga Gyan Udai Mahavidyalaya, Village - Murlipur, Ghatampur, Kanpur Nagar, U.P. had applied for grant of recognition (UP-1762) for B.P.ED. Course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the NRC its 104th meeting held on 15th 17th July, 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of Conditional recognition and ask the institution to Provide appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional Committee, and Launch official website of the Institution. Accordingly letter of conditional recognition was issued to the institution on 26.07.2006.
- AND WHEREAS the applicant institution has submitted several replies and the matter finally placed in its 147th meeting held on 16th - 17th August, 2009. The original file of the institution, along with all other related documents, allidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The College admitted students in to B.P.ED. course during academic sessions 2006-2007 and 2007-2008 without the recognition of NCTE and affiliating University also conducted the examination of students admitted during these academic session.
 - The affiliating University is directed to derecognize the degrees of students of this college admitted during academic sessions 2006 - 2007 and 2007- 2008 and intimation of having derecognize the degree should also be sent to NRC for information.
- 5. AND WHEREAS the committee decided to refused recognition for B.P.ED. Course.
- NOW THEREFORE grant of recognition Dayanand Danku Paraga Gyan Udai Mahavidyalaya, Village - Murlipur, Ghatampur, Kanpur Nagar, U.P. for the course in B.P.E.D. is hereby refused.
