**REFUSAL ORDER**

WHEREAS **SHRI SHIDDHI VINAYAK DEGREE COLLEGE (EDUCATIONAL TRUST), KHASRA NO(1357-1360) VILL.-RAIBHA, DISTT.-AGRA, UP.** had applied for grant of recognition (UP -3073) for B.ED. Course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its **144<sup>th</sup> meeting held on 12<sup>th</sup> - 14<sup>th</sup> July, 2009**, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **22.07.2009** to the applicant institution under proviso to section 14(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS the applicant institution had submitted representation. The representation of the Institution as well as other documents and materials submitted by the institution along with VTR and videography were again duly considered by the NRC 146<sup>th</sup> Meeting held on 12<sup>th</sup> - 14<sup>th</sup> July, 2009 which came to the conclusion that recognition to the said institution be refused for the following reasons.

(a) As per letter dated 30-4-2009, the Institution was directed to register the land in the name of Institution within 90 days. This has not been done within the stipulated time.

5. NOW THEREFORE grant of recognition to **SHRI SHIDDHI VINAYAK DEGREE COLLEGE (EDUCATIONAL TRUST), KHASRA NO(1357-1360) VILL.-RAIBHA, DISTT.-AGRA, UP.** for the course in **B.ED. course** in term of section 14(3) (b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
