REFUSAL ORDER

WHEREAS I.A.S.E. DEPARTMENT OF EDUCATION, UNIVERSITY OF LUCKNOW - 226007, U.P. had applied for grant of recognition (UP-973) for Innovative B.ED. Programme two years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 126th meeting held on 20th - 22nd February, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and committee decided to issue a letter of intent prior to recognition and ask the institution to **appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the management of the institution and affidavit on Rs. 10/- stamp paper from the staff appointed and staff list. Accordingly letter of intent prior to recognition was issued to the institution on 03.03.2008.**

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 142ND meeting held on 14th -16th June 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observes that:

- **The list of appointed Faculty as per NCTE Norms has not been submitted till date.**

5. AND WHEREAS the committee decided to refused recognition for Innovative B.ED. Programme.

6. NOW THEREFORE grant of recognition to I.A.S.E.DEPARTMENT OF EDUCATION, UNIVERSITY OF LUCKNOW U226007 U.P. for the course in B.ED. Innovative is hereby refused.
