REFUSAL ORDER

WHEREAS **Krishna College of Science and Information Technology, Noorpur Road, Bijnor, UP.** had applied for grant of recognition (UP-2168) for M.ED. (Part Time) course one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 114<sup>th</sup> meeting held on 21<sup>st</sup> – 22<sup>nd</sup> February, 2007, The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials, Video Recording, Original file etc. as per the case found the institutions mentioned in fit for grant of recognition of the M.ED.(Part Time) Course subject to the condition of appointment to qualified staff through duly constituted selection committee as per the norms of NCTE / State Government/ Affiliating University/ Body given effect before the commencement of the course etc. **Accordingly letter of conditional recognition was issued to the institution on 30.03.2007.**

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> – 24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for M.ED. (Part Time) Course.

6. NOW THEREFORE grant of recognition to **Krishna College of Science and Information Technology, Noorpur Road, Bijnor, UP.** for in M.ED. (Part Time) course is hereby refused.
