REFUSAL ORDER

WHEREAS INDIRA GANDHI GIRLS DEGREE COLLEGE, RAMPUR, TARAMANDAL, DISTRICT - GORAKHPUR, UP. had applied for grant of recognition (UP-2470) for B.P.ED course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 140th meeting held on 25th - 26th April, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to **issue a letter of intent prior to recognition under clause 7(9) of regulation 2007 subject to submission of photocopy of accession register and original bills of additional books purchased. Accordingly letter of intent prior to recognition was issued to the institution on 19.05.2009.**

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 145th meeting held on 26th - 28th July, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The reply of the institution has not been received in the stipulated time.

5. AND WHEREAS the committee decided to refused recognition for B.P.ED Course.

6. NOW THEREFORE grant of recognition INDIRA GANDHI GIRLS DEGREE COLLEGE, RAMPUR, TARAMANDAL, DISTRICT - GORAKHPUR, UP. for the course in B.P.ED Course is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993
