

REFUSAL ORDER

WHEREAS VIVEKANAND COLLEGE OF EDUCATION, GONDA ROAD, NEAR MATHURA BYE PASS, KOIL, ALIGARH U.P. had applied for grant of recognition (UP-2669) for M ED course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTIs.

- AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS the NRC its 126th meeting held on 20th 22th February, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter subject to condition of submission of experience certificate in respect of principal and stuff. Accordingly letter was issued to the institution on 25,03,2008.
- 4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141st meeting held on 22rd 24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 5. AND WHEREAS the committee decided to refused recognition for M.ED Course.
- NOW THEREFORE grant of recognition VIVEKANAND COLLEGE OF EDUCATION, GONDA ROAD, NEAR MATHURA BYE PASS, KOIL, ALIGARH U.P. for the course in M.ED. Course is hereby refused.
