REFUSAL ORDER

WHEREAS SHRI SAI MAHAVIDYALAYA, KHASRA NO.-55/1, VPO-FATEH PUTHI, DISTT.-BAGHPAT, UP, had applied for grant of recognition (UP-3247) for B.ED course of one years(s) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 145<sup>th</sup> meeting held on 26<sup>th</sup> - 28<sup>th</sup> July, 2009. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to seek clarification on following points:-

- (i) The built up area of Multipurpose hall in approved building plan and affidavit submitted by Management do not match.
- (ii) There is no Faculty to teach Methods of teaching physics, Mathematics, Geography, etc.

Accordingly clarification letter was issued to the institution on 31.07.2009.

4. AND WHEREAS the applicant institution has submitted reply date 18.08.2009. The matter was placed in its 148<sup>th</sup> meeting held on 28<sup>th</sup> - 30<sup>th</sup> August, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The deficiencies with respect to Faculty and Multipurpose still exit.

5. AND WHEREAS the committee decided to refused recognition for B.ED Course.

6. NOW THEREFORE grant of recognition SHRI SAI MAHAVIDYALAYA, KHASRA NO.-55/1, VPO-FATEH PUTHI, DISTT.-BAGHPAT, UP, for the course in B.ED Course is hereby refused.
