ORDER

WHEREAS in terms of Section **15(1)** of the NCTE Act, 1993 **Innovative Institute of Education and Technology, Plot No. 6, Knowledge Park-2, Greater Noida, District- G.B. Nagar, Uttar Pradesh**, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed** Course of **One year** duration with an annual intake of **100 (One Hundred Only)** students on **12.07.2006** and NRC granted recognition /permission to the Institution for conducting **B.ED** Course for **One Year** duration with an annual intake of **100** Students under clause 7(12) of NCTE Regulations, 2007 vide order ; no. **F.NRC/NCTE/F-7/UP-2156/2008/50635-41** dated **14.05.2008**

2. AND WHEREAS a complaint was received on 23.02.2009 at NCTE HQtrs, Wing -II, Hans Bhawan, 1, Bahadur Shah Zafar Marg, New Delhi, and the matter was placed before the NRC and the committee decided to cause inspection under section 17 of the NCTE Act.

3. AND WHEREAS the NRC NCTE caused an inspection of the said institution on 10.08.2009 under section 17 of the NCTE Act. The original file of the institution as well as other documents and materials submitted by the institution along with VTR, videography were duly considered by the NRC in its **148th** Meeting held on **28th to 30th August 2009** the committee decided to issue a show cause notice before withdrawing the recognition to the B.ED course on account of the show cause notice.

4. AND WHEREAS the institution has submitted a representation to the NRC NCTE, on **25.09.2009**, the original file of the institution as well as other documents and materials submitted by the institution were again duly considered by the NRC in its **150th** Meeting held on **09th to 11th October 2009** the committee observed the following:

- Reply is not satisfactory.
- Deficiencies still exist.

5. AND WHEREAS the committee decides to withdraw B.ED recognition from the academic session 2010-2011.

6. NOW THEREFORE the recognition to **Innovative Institute of Education and Technology, Plot No. 6, Knowledge Park-2, Greater Noida, District- G.B. Nagar, Uttar Pradesh** for B.ED course is hereby withdraw under section 17(3)(b) of the NCTE Act 1993 from the academic session 2010-2011.
