REFUSAL ORDER

WHEREAS Shukdeo Prasad Tripathi Mahavidyalaya, VPO - Bhathahin Khurd (Shukdeo Nagar), Via - Fazilnagar, District - Kushinagar, UP. had applied for grant of recognition (UP-2391) for M.Ed course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 121st meeting held on 07th - 10th September, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and asked the institution to **appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules, along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution and Affidavit on Rs. 10/- stamp paper from the Staff appointed and staff list. Accordingly letter of intent prior to recognition was issued to the institution on 15.09.2007.**

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in its 141st meeting held on 22nd - 24th May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for M.Ed. course.

6. NOW THEREFORE grant of recognition Shukdeo Prasad Tripathi Mahavidyalaya, VPO - Bhathahin Khurd (Shukdeo Nagar), Via - Fazilnagar, District - Kushinagar, UP. for the course in M.Ed. course is hereby refused.
