REFUSAL ORDER

WHEREAS **MOTHERHOOD INSTITUTE OF TECHNOLOGY, BADDERUDDIN NAGAR, NANU, SARDHANA, MEERUT, U.P.**, of recognition (**UP-3401**) for **B.ED** Course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **31.10.2008**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 148th Meeting held on **28th to 30th August 2009**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued Show Cause Notice to the applicant institution on **31.08.2009**.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 150th Meeting held on **09th to 11th October 2009** and the committee observes that:

- Reply is not satisfactory
- Deficiencies still exist

5. AND WHEREAS Hence, the committee decides to close the file, the FDR in original, if any may be returned.

NOW THEREFORE grant of recognition to **MOTHERHOOD INSTITUTE OF TECHNOLOGY, BADDERUDDIN NAGAR, NANU, SARDHANA, MEERUT, U.P.** for the course in **B.ED** course in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. **455800PQ00000203** & FDR of Rs. 3.00 Lakhs bearing No. **455800PQ00000212** are returned herewith.
