REFUSAL ORDER

WHEREAS in terms of Section **15(1)** of the NCTE Act, 1993 **DEEPANSHU WOMENS DEGREE COLLEGE, DELHI ROAD, , SAHARANPUR, , SHARANPUR-247001 UTTAR PRADESH** had applied for grant of recognition (UP-2485) for **BTC** Course of 2 year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS In its 129th meeting held on 7th - 8th May, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of clarification. Accordingly letter was issued.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed before Northern Regional Committee in its 140 meeting held on 25th - 26th April, 2009. The original file of the institution along with all other related documents, affidavits Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time etc. were considered and the committee observed that:-

5. NOW THEREFORE grant of recognition to **DEEPANSHU WOMENS DEGREE COLLEGE, DELHI ROAD, SAHARANPUR, , SHARANPUR-247001 UTTAR PRADESH** for the course in M.ED in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
