#### REFUSAL ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 R.V. HIGHER EDUCATION & TECHNICAL INSTITUTE, VILLAGE - CHITHERA, POST - DADRI, DISTT. - G.B. NAGAR, U.P. had applied for grant of recognition (UP-1663) for BTC. Course of 2 year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS In its 109<sup>14</sup> meeting held on 11<sup>71</sup>-12<sup>71</sup> November,2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a conditional recognition on 14.11.2006 to the applicant institution under provise to section 15 (1) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation on its behalf.
- 4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was again placed before Northern Regional Committee in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> -24<sup>th</sup> May, 2009. The committee observed that:-
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 5. NOW THEREFORE grant of recognition to R.V. HIGHER EDUCATION & TECHNICAL INSTITUTE, VILLAGE CHITHERA, POST DADRI, DISTT. G.B. NAGAR, U.P for the course in BTC. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they may prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
