REFUSAL ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 INSTITUTE OF LAW & ACADEMIC STUDIES, E-211, KAVI NAGAR INDUSTRIAL AREA, SECTOR - 17, GHAZIABAD, UTTAR PRADESH had applied for grant of recognition (UP-1321) for BTC. - 4. AND WHEREAS the applicant institution has not submitted reply of the above said order. The matter was placed before Northern Regional Committee in its 141st meeting held on 22nd 24th May, 2009. The committee observed that:-
 - . The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- NOW THEREFORE grant of recognition to BAREILLY COLLEGE, BAREILLY COLLEGE,
 PO- SHYAMGANJ, , BAREILLY-243005 for the course in M.ED. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
