REFUSAL ORDER

WHEREAS **INSTITUTE OF PROFESSIONAL STUDIES, KH-3, KAVI NAGAR, GHAZIABAD-201002, UP.** of recognition (**UP-1763**) for M.ED Course of One years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **07.08.2006**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its **113th** Meeting held on **18th to 19th January 2007**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued letter of conditional Recognition to the applicant institution on **24.01.2007** and clarification letter issued on **12.04.2008**.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on **30.07.2007**. The matter was again placed before the NRC in its **141st** Meeting held on **22nd to 24th May 2009** and the committee observes that:

- The list of appointed faulty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS Hence, the committee decides to refuse recognition and return FDR's if submitted.

6. NOW THEREFORE grant of recognition to **INSTITUTE OF PROFESSIONAL STUDIES, KH-3, KAVI NAGAR, GHAZIABAD-201002, U.P.** for the course in M.ED course in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. **213327** is returned herewith.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
