REFUSAL ORDER

4 NOV 2009

WHEREAS SUBHAKR MAHILA POST GRADUATE COLLEGE, S-9/92-93, KHAJURI, PANDEYPUR CROSSING, VARANASI - 221002, had applied for grant of recognition (UP-2052) for M.Ed course of one years(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS the NRC its 131<sup>st</sup> (3<sup>rd</sup> Sitting) meeting held on 29<sup>th</sup> - 31<sup>st</sup> August, 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and asked the institution to (i) appointment of faculty/staff by a duly constituted selection committee and ensures selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution is required to be submitted. (ii) The institution shall launch its own website covering, inter- alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure instructional facilities and the particulars of their proposed teaching and non - teaching staff etc. (iii) Admission shall not be made until formal recognition order under Para 7(11) of the Regulations dated 10<sup>th</sup> December 2007 is issued by the Northern Regional Committee, NCTE and affiliation is obtained from the examining body. Accordingly letter of intent prior to recognition was issued to the institution on 04.09.2008.

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> - 24<sup>th</sup> May, 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE Published from time to time, etc. were considered and the committee observed that:

- The list of appointed Faculty as per NCTE Norms has been submitted till date.

5. AND WHEREAS the committee decided to refused recognition for M.Ed. course.

6. NOW THEREFORE grant of recognition SUDHAKR MAHILA POST GRADUATE COLLEGE, S-9/92-93, KHAJURI, PANDEYPUR CROSSING, VARANASI - 221002. for the course in M.Ed. course is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.

8. The original FDR no. 634322, Rs. Three lacs, dated 07.03.2008, and FDR no. 634314, Rs. five lacs, dated 29.02.2008, are return herewith.
