REFUSAL ORDER

19 MAY 2009

WHEREAS **MUSLIMA GIRLS DEGREE COLLEGE, SIR-SYED NAGAR, KARULA, MURADABAD, U.P.** had applied for grant of recognition (UP - 2176) for B.ED. ADDITIONAL INTAKE ONE year(s) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 140th meeting held on 25th -26th April 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 12.5.2009 to the applicant institution under proviso to section 15(3)(b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS, keeping in view the direction of Hon'ble High Court of Delhi in his order dated 12.5.2009 in W.P.(C) 300/2009 to dispose the case by 18.5.2009 and severe nature of deficiencies which were existing as per visiting team report and records available in the file of the institution. It was decided after discussion with competent authority to obey the direction of Hon'ble High Court of Delhi to dispose the case by 18.5.2009 and therefore the recognition is refused for the following reasons:

- 2657 books are not sufficient even for 100 students.
- Multipurpose hall is not available.
- Built-up area is not sufficient for additional intake.
- Facilities for games and sports are not available.
- Eight computers are not sufficient even for 100 students.
- Affidavit on Rs. 10 stamp paper from each staff member on the prescribed format is not submitted.
- Affidavit on Rs. 100 stamp paper from the Management of the institution about the staff on the prescribed format is not submitted.
- As per affiliating University letter dated 13.06.2008, only four teaching staff members are approved.
- Built-up area has not been earmarked for B.Ed. programme.

5. NOW THEREFORE grant of recognition to **MUSLIMA GIRLS DEGREE COLLEGE, SIR-SYED NAGAR, KARULA, MURADABAD, U.P.** for the course in **B.Ed. additional intake** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
7. The institution shall maintain & update the web-site as per provisions of NCTE Regulations.
