ORDER

15 SEP 2010

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 **Manyawar Kanshi Ram Mahavidyalaya, Vill- Pure Gosain, Post- Dalmau, Tehsil- Dalmau, District- Raibrelly- 229207, Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of One year duration with an annual intake of 100 (One hundred Only) students on 30.10.2008.

AND WHEREAS, the inspection of the institution was conducted on 27.08.2009.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its 149<sup>th</sup> Meeting held on 13<sup>th</sup> September & 14<sup>th</sup> September, 2009 decided to issue letter under clause 7(9) of Regulations 2007 & accordingly, letter of Intent prior to recognition was issued on 25.09.2009. The applicant Institution submitted the representation to the NRC, NCTE, Jaipur on 16.10.2009.

AND WHEREAS, the matter was placed before NRC in its 152<sup>nd</sup> Meeting held on November 23-25, 2009, the Committee decided to allow the college to meet the following deficiencies within 90 days:-

- The Website has not been developed as per NCTE norms.
- Qualification of Dr (Ms.) Suman Lata Singh does not match with the qualification as mentioned in affidavit of Rs. 100.

AND WHEREAS, reply submitted by the institution on 05.12.2009 was placed before NRC in its 154<sup>th</sup> Meeting held on January 09-11, 2010 & it was decided to refuse recognition for B.Ed. course and return FDRs. Accordingly order issued on 19.01.2010 on the following points:-

- Appointed lecturer Dr. Suman Lata Sharma has 45.44% marks in M.Ed. as against the requirement of 50%. Hence, she is not qualified.
- Mrs. Deepti Arora appointed as HOD does not have Ph.D. degree. Hence, she is not qualified.
- The college does not have qualified faculty as per NCTE norms for B.Ed. course.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 11.02.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.

AND WHEREAS, after perusal of documents, Memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the hearing, the Council came to the conclusion that there is adequate ground to accept the appeal and set-aside NRC's order dated 19.01.2010 and remand back the case to NRC vide order dated 31.05.2010 for issuance of formal recognition order under clause 7 (11) of the NCTE Regulations, 2009 immediately. The decision of the Council would, however, be operative from the date of withdrawal of the ban on further recognition of B.Ed. course in the State of Uttar Pradesh.

AND WHEREAS, the matter was placed before NRC in its 162<sup>nd</sup> Meeting held on from June 24-27, 2010 & the Committee decided to implement of decision of Appeal Committee.

AND WHEREAS, the NCTE has issued letter No.48-6/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on 26<sup>th</sup> July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session 2011-2012 and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its 166<sup>th</sup> Meeting held on 9<sup>th</sup> September, 2010 and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations be issued from the session 2010-2011 subject to the following condition:-

- i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section **14(3)** (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Manyawar Kanshi Ram Mahavidyalaya, Vill- Pure Gosain, Post- Dalmau, Tehsil- Dalmau, District- Raibrelly- 229207, Uttar Pradesh** for conducting **B.Ed Course** of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session **2010-2011** under clause 7(11) of NCTE Regulations subject to the following conditions:-

- (i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- (ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.


If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
