ORDER

WHEREAS in terms of section 15(1) of the NCTE Act, 1993 Kanchan Singh Bhooli Devi Mahavidyalaya, Village – Bhikhanapur, Shajahanpur (Ninaya), Strict – Raipur to Gajner Road, Post – Sarwan Khera, Tehsil – Akabarpur, District – Kanpur Dehat – 209221, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of permission for B.Ed Course of one year duration with an additional annual intake of 100 (One Hindered Only) students on 20.11.2007.

AND WHEREAS, the inspection of the said institution was conducted on 06/10/2008.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report, videography and the input received from recommendation of the State Government, the Northern Regional Committee in its 135th Meeting held from 22nd and 23rd December, 2008 decided that as per the negative recommendation of Uttar Pradesh State Govt. vide order No. 1441/ सत्तर-6/2008-2(192)/2008 dated 09/06/2008 application of the institution be rejected. Accordingly the application of said intuition was rejected vide order dated 21/01/2009.

AND WHEREAS, the institution had preferred an appeal before the Council (NCTE, New Delhi) under section 18 of the NCTE, Act, 1993 against the order of NRC. The case was remanded back by the Council vide order dated 09/12/2009 to NRC with direction to issue letter of intent prior to grant of recognition under clause 7 (9) of NCTE, Regulations 2007 within 15 days of issue of this order. Accordingly letter dated 7/01/2009 was issued to the institution.

AND WHEREAS, the reply of the institution was considered by NRC in its 135th meeting and as per the decision taken by NRC, recognition was refused vide order dated 01/02/2010. The institution had again preferred an appeal before the Council under section 18 of NCTE, Act, 1993 against the order of NRC. The order of NRC was set – aside by the Council vide order dated 31/05/2010 with direction to NRC to issue formal recognition order under clause of 7 (11) of the NCTE, Regulations, 2009.

NOW THEREFORE, in compliance of order dated 31/05/2010 passed by the Council (NCTE, New Delhi) under clause 18 of NRC Act, 1993, and in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Kanchan Singh Bhooli Devi Mahavidyalaya, Village – Bhikhanapur, Shajahanpur (Ninaya), Strict – Raipur to Gajner Road, Post – Sarwan Khera, Tehsil – Akabarpur, District – Kanpur Dehat – 209221, Uttar Pradesh for B.Ed Course of with an additional annual intake of 100 seats from the academic session 2010-2011 under clause 7(11) of NCTE Regulations, 2009 subject to the following conditions as per the decision taken by NRC in its 166th Meeting. The total seats of the institution will be 200 (100 existing + 100 additional).

- i) The admission of the students against additional seats shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011 failing which admission for additional seats shall be given from the academic session 2011-2012.
- ii) Formal recognition / permission against additional seats will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the academic session 2011-2012.
- iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.

- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.


The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
