ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Panna Mahavidyalaya Shiksha Sansthan Samiti, Plot No. – 870, VPO – Kushan Brahman Bhimpura No. 01, Tehsil - Bilthara Road, District – Ballia – 221716, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 (One Hindered Only) students on 23.10.2008.

AND WHEREAS, the matter was placed before NRC in its 139th Meeting held from 10th and 12th April, 2009 & as per decision of NRC, the application was closed vide order dated 17.05.2009.

AND WHEREAS the above said Institution, thereafter preferred an appeal before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remanded back to NRC by the Council vide order dated 07.08.2009 with direction to NRC to cause Inspection of the Institution. As per direction of the Council, Inspection was conducted on 24.01.2010.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 156th Meeting held from 22nd and 23rd February, 2010 & committee decided that the letter under clause 7(9) of regulations 2007 be issued to the institution. Accordingly letter of intent under clause 7(9) was issued to the institution on 08.03.2010. & reply of the same was received on 28.04.2010.

AND WHEREAS, the matter was placed before NRC in its 160 Meeting held from 18th and 20th May, 2010 & committee decided to issue show cause notice to the institution. Accordingly a show cause was notice issued to the institution on 01.01.2010 & reply of the same was received on 17.06.2010.

AND WHEREAS, the matter was placed before NRC in its 162nd Meeting held from 24th to 27th June, 2010 & as per decision of NRC recognition was refused vide order dated 21.07.2010.

AND WHEREAS, the above said Institution, thereafter preferred an appeal before Council (NCTE), New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council had passed order dated 22.07.2010 in the appeal filed by the institution. The order of NRC was reversed by the Council with a direction to NRC to issue formal recognition order to the institution within 15 days of the issue of the appellate order.

AND WHEREAS, in compliance of order dated 27.09.2010 passed by the Council under clause 18 of NRC Act, 1993, and in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Panna Mahavidyalaya Shiksha Sansthan Samiti, Plot No. – 870, VPO – Kushan Brahman Bhimpura No. 01, Tehsil - Bilthara Road, District – Ballia – 221716, Uttar Pradesh for B.Ed Course of with an annual intake of 100 seats from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions.

- The admission of the students shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011 failing which admission for additional seats shall be given from the academic session 2011-2012.
- Formal recognition / permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.

- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.


The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
