ORDER

WHEREAS Pt. Jag Narayan Shukla, Gramodaya Mahavidyalaya Ranipur Pahari, Tarabganj, Gonda, U.P. has submitted an application to the NRC for grant of recognition/permission for conducting B.ED Course of one year duration with an annual intake of 100 (One Hundred only) on 29.12.2005.

2. AND WHEREAS, the competent authority has constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS, in its 113<sup>th</sup> Meeting held on 18<sup>th</sup> to 19<sup>th</sup> January 2007 the Northern Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution and committee decided to issue a letter of conditional recognition and ask the institution to (1) Qualification of faculty members. As per NCTE norms and standards and inform the Regional Committee, accordingly letter of intent prior to recognition was issued to the institution on 24.01.2007.

4. AND WHEREAS, the applicant institution has not submitted reply. The matter was placed in NRC in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May, 2009 and decided to refuse recognition and return FDR's if submitted. Accordingly letter was issued to the institution on 09.07.2009. The above said institution, thereafter preferred an appeal dated 10.08.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.

5. AND WHEREAS, after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the Council, reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 09.07.2009 and remand the case to NRC, to direct the appellant to furnish copies of the relevant communication to the NRC afresh for re-examination of the matter.

6. AND WHEREAS, the matter was placed before the committee in its 151<sup>st</sup> Meeting held on 20<sup>th</sup> to 21<sup>st</sup> and committee decided to process the file as per the direction of the Appeal Committee. Accordingly letter was issued to the institution on 22.12.2009.

7. AND WHEREAS, the applicant institution has not submitted the representation to the NRC NCTE, Jaipur. The matter was considered by the NRC in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March 2010 and the committee observes:

- The Institution has not replied letter F.NO./ NRC/ NCTE/ UP-2034/ Appeal/ 152 meeting/ 2009/ 14018 dated 22 December 2009

8. AND WHEREAS, the committee decided to close the file.

9. NOW THEREFORE recognition to Pt. Jag Narayan Shukla, Gramodaya Mahavidyalaya Ranipur Pahari, Tarabganj, Gonda, U.P. for the course in B.Ed in term of section 14(3) (b) of the NCTE Act, 1993 is hereby refused.

10. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
