WHEREAS Swami Vivekanand College, Bye Pass Road, Vill- Mustafabad, Post-Pachenda Kala, Muzaffar Nagar, Uttar Pradesh had applied for grant of recognition for B.Ed Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 17.10.2007.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution and the committee decided to issue a Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution on 23.08.2008.
- AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE on 29.08.2008. The matter was considered by the committee in its 138 Meeting and decides to issue letter of intent prior to recognition to the institution, accordingly letter was issued to the institution on 13.04.2009. The applicant institution has submitted its representation to the NRC NCTE on 04.05.2009. The matter was considered by the Committee in its 141 Meeting and the committee decided to refuse recognition and return FDR's if submitted. Accordingly order was issued to the institution on 08.07.2009.
- AND WHEREAS the above said institution filed a writ petition no. 70131/09 in the Hon'ble High Court of Allahabad, U.P. The Matte was considered by the Committee in its 155<sup>th</sup> Meeting and the committee decided to issue a clarification letter to the institution. Accordingly the letter was issued to the institution on 01.02.2010 and corrigendum was issued on 10.02.2010. The applicant institution submitted its representation to the NRC NCTE Jaipur on 02.03.2010. The matter was placed before the committee in its  $157^{th}$ meeting and the Committee decides to issue show cause notice to the institution. Accordingly show cause notice was issued to the institution on 31.03.2010
- AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE Jaipur on 12.04.2010. The matter was placed before the committee in its **158**<sup>th</sup> Meeting held on **19**<sup>th</sup> **to 22**<sup>nd</sup> **April, 2010** and the committee observes:
  - HOD Dr. Tirath Pal Singh and three teachers, namely, Shri Niraj Kumar, Ms. Poonam Rani Sharma and Mr. Mohd. Nasir are not qualified as per NCTE norms for B.Ed.
- AND WHEREAS the committee decides to refuse recognition to B.Ed. course. 7.
- NOW THEREFORE grant of recognition to Swami Vivekanand College, Bye Pass Road, Vill- Mustafabad, Post- Pachenda Kala, Muzaffar Nagar, Uttar Pradesh for **B.Ed** Course under section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
