Whereas V.T. College of Education, VPO- Mohiuddinpur, Tehsil- Meerut, District- Meerut, Uttar Pradesh had applied for grant of recognition for **100 seats** in **B.Ed** course of **one year** duration under section 14(1) of the NCTE Act, 1993 to the NRC, NCTE on 14.03.2008.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on 09.06.2009 and submitted its report 18.06.2009.

And whereas in its 144th meeting held on 12th to 14th July, 2009 committee Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 22.07.2009.

And whereas the institution submitted its reply to the show cause notice decided by the NRC on 23.07.2009 & 24.07.2009. The matter was again placed before the Northern Regional Committee in its 145th meeting held on 26th to 28th July, 2009 and the committee decides to refuse recognition for B.Ed course. Accordingly, refusal order was issued on 28.08.2009.

And whereas the institution filed a writ petition no. 69752/2009 in the Hon'ble High Court of Allahabad. The Court order dated 21.12.2009 and the original file of the institution along with all other documents, Act of NCTE 1993, Regulations and Guidelines of NCTE published form time to time were considered by the committee in its 154th Meeting held on 09th to 11th January, 2010 and the committee decides to VT may be sent.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on 24.02.2010 and submitted its report on 06.03.2010.

And whereas in its 159th meeting held on 28th April to 01st May, 2010 Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 15.05.2010.

And whereas the institution submitted its reply to the show cause notice decided by the NRC on 16.06.2010. The matter was again placed before the Northern Regional Committee in its 162nd meeting held on 24th to 27th June, 2010 and the committee decided as follows:

The deficiencies communicated to the Institution through letter number NRC / NCTE /UP-2946/159 meeting /2010/22253 dated 15 May 2010 still exist.

Now therefore grant of recognition to V.T. College of Education, VPO- Mohiuddipur, Tehsil- Meerut, District- Meerut, Uttar Pradesh for the course in B.Ed in terms of section 14(b) of the NCTE Act, 1993, is hereby refused and the file of the institution is closed.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days a format for which is enclosed.

Also ordered that a copy of this order to published in the Official Gazette.
