Whereas Narva Deshwar College, VPO- Chinhat, Tehsil- Lucknow, District- Lucknow, Uttar Pradesh had applied for grant of recognition for **100 seats** in **B.Ed** course of **one** year duration under section 14(1) of the NCTE Act, 1993 to the NRC, NCTE on 31.10.2008.

And whereas the original file of the institution as well as other relevant materials furnished by the applicant institution were considered by the committee in its 141st meeting held on 22nd to 24th May, 2009 and the committee decides to close the file and return FDR's if submitted. Accordingly closed order was issued to the institution on 23.04.2010.

And whereas the said institution file a writ petition no. 7879(M/S B)/2005 in the Hon'ble High Court of Lucknow. The court order dated 04.01.2006 and the original file of the institution along with all other documents, Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 159th meeting held on 28th April to 01st May, 2010 and the committee decides to issue show cause notice to the institution. Accordingly show cause notice was issued to the institution on 11.05.2010.

And whereas the institution submitted its reply to the show cause notice decided by the NRC on 11.06.2010. The matter was again placed before the Northern Regional Committee in its 162nd meeting held on 24th to 27th June, 2010 and the committee observes the following:

- The deficiencies communicated to the Institution vide letter NRC / NCTE / UP-3469 / 159 Meeting / 2010 / 21787 dated 11 May 2010 still exist.

Hence the committee decides to close the file and return FDRs if submitted.

Now therefore grant of recognition to Narva Deshwar College, VPO- Chinhat, Tehsil- Lucknow, District- Lucknow, Uttar Pradesh for the course in B.Ed in terms of section 14(b) of the NCTE Act, 1993, is hereby closed.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days a format for which is enclosed.

Also ordered that a copy of this order to published in the Official Gazette.
