- 2. AND WHEREAS the concerned University, Mahatma Jyotiba Phule Rohilkhand University, Bareilly, Uttar Pradesh issued an order vide no. E.S.-358 G.S. dated 08.03.2006 communicating the decision not to grant affiliation to the institution for running B.Ed Course.
- 3. AND WHEREAS, the matter was considered by the NRC in its 102^{nd} Meeting, whereby the committee decided to serve Notice U/s 17 of NCTE Act. Accordingly Show Cause Notice was issued to the institution on 10.07.2006.
- 4. AND WHEREAS the institution has not submitted the representation to the NRC NCTE, the original file of the institution as well as other documents were duly considered by the NRC in its **161**st Meeting held on **26**th **to 29**th **May, 2010** the committee observed the following:
 - The letter number NRC / NCTE / F-7 / UP-879 / 2006 / 2575 2576 dated 10 July 2006 has not been replied till date.
- 5. AND WHEREAS the committee decides to close the file.
- 6. NOW THEREFORE the recognition to **Vivek College of Education, Noorpur Bijnor Road, Garhwala, Tehsil Bijnor, UP** for **B.ED** course is hereby withdrawn under section 17(3)(b) of the NCTE Act 1993.
- 7. If the institution is not satisfied by the above order they can prefer an appeal to the council under sections 18 of NCTE Act, 1993.
