WHEREAS Noida College of Physical Education, I- Block, Main Road, Sector- 22, Noida, Gautam Budh Nagar, Uttar Pradesh has submitted an application to the NRC for grant of recognition/permission for conducting M.P.Ed Course of two years duration with an annual intake of 30 (Thirty only) on 31.12.2004.

2. AND WHEREAS the Northern Regional Committee has constituted Visiting Team to visit the institution, which has visited the institute on 23.10.2006 and submitted its report.

3. AND WHEREAS the matter was considered by the NRC in its 113th Meeting and the committee decided that Recognition be granted to the M.P.Ed course of two years duration with an annual intake of 30 (Thirty only) subject to the condition of submission of the list of appointed qualified staff by following due selection procedure before the commencement of the course. The institution is required to submit documentary proof with regard to depositing of Reserve fund of Rs. 3.00 lacs. Accordingly letter was issued to the institution on 24.01.2007 and 09.07.2007. The applicant institution had not submitted the representation to the NRC.

4. AND WHEREAS the original application submitted by the institution, Norms and Standards, Rules and Regulations & NCTE Act were placed before the Northern Regional Committee in its 160th Meeting held on 18th to 20th May, 2010 and the committee observed the followings:

- The Institution was issued 7(9) which have not been replied till date.

Hence, the committee decides to close the file.

5. NOW THEREFORE recognition to Noida College of Physical Education, I- Block, Main Road, Sector- 22, Noida, Gautam Budh Nagar, Uttar Pradesh for the course in M.P.ED in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
