WHEREAS, the **Shree Balaji Degree College, VPO- Kurali, Post- Janikhurd, District- Meerut, U.P.** was granted recognition for running M.Ed course of one year duration with an annual intake of 25 students vide its office order no. F.NRC/NCTE/F-3/UP-2743/2008/66430-36 dated 02.12.2008.

2. AND WHEREAS, the inspection of the institution was conducted on 26.05.2009 under section 17 of the NCTE Act, 1993. Northern Regional Committee in its 142nd Meeting held on 14th to 16th June, 2009, after considering the report of the visiting team as well as other relevant materials furnished by the institution, that the applicant institution does not fulfill the requirements and issued a show cause notice to the institution on 23.06.2009 to the applicant institution under section 17 of the NCTE Act, 1993. The applicant institution has submitted representation to the NRC NCTE, Jaipur on 06.10.2009. The matter was placed before the committee in its 150th Meeting held on 09th to 11th October, 2009 and decided to withdraw the recognition to M.Ed form the academic session 2010-2011. Accordingly withdrawn letter was issued to the institution on 12.11.2009. The above said institution, thereafter preferred an appeal dated 06.01.2010 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.

3. AND WHEREAS, after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to remand back the case to NRC for issue of a speaking order. The matter was placed before the NRC in its 157th Meeting held on 24th to 27th March 2010 and the committee observes:

- The deficiencies already communicated to the Institute still exist.

4. AND WHEREAS, the committee decides to refuse recognition for M.Ed. course.

5. NOW THEREFORE recognition to **Shree Balaji Degree College, VPO- Kurali, Post- Janikhurd, District- Meerut, U.P.** for the course in **M.ED** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
