ORDER

WHEREAS Janta Maha Vidyalaya, VPO- Ajitmal, Tehsil- Auraiya, District- Auraiya, U.P. had applied for grant of permission for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 22.08.2007.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 154<sup>th</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> January, 2010, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue Show Cause Notice to the applicant institution on 18.01.2010.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 04.02.2010. The matter was placed before the committee in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March, 2010, and observes:

- The deficiencies communicated to the Institution through letter F.No./NRC/NCTE /UP-2590/154<sup>th</sup> meeting/ 2009 / 15137 dated 18 January 2010 still exist.

5. AND WHEREAS the committee decides to refuse recognition for B.Ed. course.

6. NOW THEREFORE grant of permission to Janta Maha Vidyalaya, VPO- Ajitmal, Tehsil- Auraiya, District- Auraiya, U.P. for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
