WHEREAS Shree Ram Institute of Education, Vill- Timakiya, Post- Jami Khurd, Tehsil- Meerut, District- Meerut, U.P. had applied for grant of recognition for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 05.08.2008.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 154<sup>th</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> January, 2010, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution. was satisfied that the committee decided to issue **Show Cause Notice** to the applicant institution on 19.01.2010.

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 25.01.2010 & 19.03.2010. The original file of the institution as well as other documents and materials submitted by the institution were duly considered by the NRC in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March, 2010, and decides:

- The deficiencies in respect of common room and toilets for girls still exist.

5. AND WHEREAS the committee decides to refuse recognition for B.Ed. course.

6. NOW THEREFORE grant of recognition to Shree Ram Institute of Education, Vill- Timakiya, Post- Jami Khurd, Tehsil- Meerut, District- Meerut, U.P. for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
