ORDER

WHEREAS **H.L.M. College, KL-114, VPO- Ghaziabad, Tehsil + District- Ghaziabad, Uttar Pradesh** had applied for grant of permission for M.ED Course of One year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **16.11.2007**.

2. AND WHEREAS the application of the institution was refused by the NRC in its 143rd Meeting of NRC held on 27th to 29th June, 2009 and refusal order was issued on 24.07.2009. The above said institution, thereafter preferred an appeal dated 24.09.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.

3. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was a justification to remand back the case to NRC for issue of a revised order citing the correct position in its refusal order.

4. AND WHEREAS the matter was considered by the committee in its **157th meeting held on 24th to 27th March, 2010** and the committee observes the following:

- **As per appeal committee, the refusal order stating correct position is to be issued**

5. AND WHEREAS the following was the ground of refusal was:

- **The Professor has not been selected through dully constituted selection committee as per NCTE norms for M.Ed.**

6. NOW THEREFORE grant of recognition to **H.L.M. College, KL-114, VPO- Ghaziabad, Tehsil + District- Ghaziabad, Uttar Pradesh** for the course in **M.ED** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
