ORDER

Whereas S.S. Degree College, Vill- Gopalpura, Post- Shamsabad, Tehsil- Fatehabad, District- Agra, Uttar Pradesh had applied for grant of recognition for **100 seats** in **B.Ed** course of **one** year duration under section 14(1) of the NCTE Act, 1993 to the NRC, NCTE on 29.12.2007.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on 26.03.2010 and submitted its report 29.03.2010.

And whereas in its 159th meeting held on 28th April to 01st May, 2010 Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the Institution on 15.05.2010.

The institution submitted its reply to the show cause notice decided by the NRC on 14.06.2010. The matter was again placed before the Northern Regional Committee in its 162nd meeting held on 24th to 27th June, 2010 and the committee decided as follows:

- The deficiencies communicated to the Institution through letter number NRC / NCTE / UP-2783 / 159 meeting / 2010 / 22251 dated 15 May 2010 still exist.

Now therefore grant of recognition to S.S. Degree College, Vill- Gopalpura, Post- Shamsabad, Tehsil- Fatehabad, District- Agra, Uttar Pradesh for the course in B.Ed in terms of section 14(b) of the NCTE Act, 1993, is hereby refused.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days a format for which is enclosed.

Also ordered that a copy of this order to published in the Official Gazette.
