#### ORDER

WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, 1993 **Shyam Lal Saraswati Mahavidyalaya, Saaswati Vihar, Shikarpur, Bulandshahar, Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.Ed. Addl. Course of One year duration with an annual intake of 100 (One Hundred Only) students on **05.12.2007**.

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 139th Meeting held on 10th to 12th April, 2009 and the committee decided to issue letter of intent to prior to recognition under clause 7(9) of regulation 2007. The institution is asked to submit the selection committee minutes of faculty for existing and proposed course. Accordingly letter of intent to prior to recognition was issued to the institution vide NCTE letter no. F.NO.NRC/NCTE/F-7/UP-2728/2009/1555-56 dated 02.05.2009.
- AND WHEREAS the applicant institution submit its reply with conditions mentioned in the conditional recognition to Northern Regional Committee, NCTE, Jaipur and the matter was placed before NRC in its 142<sup>nd</sup> Meeting held on 14<sup>th</sup> to 16<sup>th</sup> June, 2009 and the committee decided to issue a clarification to the institution and a clarification letter was issued to the institution on 22.07.2009.
- AND WHEREAS the applicant institution submit its reply to the Northern Regional Committee on 13.07.2009 and the matter was placed before the NRC in its 145th Meeting held on 26th - 28th July, 2009 and the committee decided to refuse the recognition for B.ED Course of one year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F73/UP-2728/145 Meeting/2009/9042-48 dated 28.08.2009. The above said institution, thereafter preferred an appeal dated 12.10.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal set-aside NRC's order dated 28.08.2009 with the direction to the NRC to issue recognition order. Accordingly, the appeal was allowed, NRC's order dated 28.08.2009 was setaside and the case was remand back to NRC for issue or recognition order under clause 7(11) of the NCTE Regulation.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Shyam Lai Saraswati Mahavidyalaya, Saaswati Vihar, Shikarpur, Bulandshahar, Uttar Pradesh for conducting B.Ed Addl. Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
